- A motion was made and approved to amend the Post Bylaws and Constitution to provide a zero tolerance policy in regards to sexual harassment, on Post 291 property.

Discussed the UCI Sailing class in Newport Harbor; if a veteran completes the class the Post will pay 70% of the cost at that time.

The Commander announced that we received plaques from Team Dark Horse and the Marines for our involvement in the Holiday Party for 300 to 600 Marines from Camp Pendleton at Mariner's Church in Irvine.
