The Auxiliary is donating two TVs, the SONS is donating three TVs, and the Balboa Bay Club is donating two TVs. The TVs are being delivered on Saturday, September 23, 2017. As required by our By-laws, this donation request was assigned to the Post 291 Donation Committee.

In addition, the Auxiliary's "Troop Shipping Program" that goes out from March Air Force Base was discussed.

- a) SAL Tim Sullivan: Reported that the preparation for the Boat Parade and the concierge service being provided to the Post are going well.
 - Bill Dunn, SONS 2nd Vice has resigned, and the SONS requested that Steve Porter be approved by the E-Board as his replacement. It was discussed in Close Session.
 - The SONS requested that the E-Board approve the SONS' Boat Parade event.
 - **M/S/C**: A motion was made for a one-time waiver of the 90 day requirement for the SONS to present a budget and a plan for the SONS' Boat Parade event, and that they must present it to the E-Board at the October meeting. The motion was approved.
- b) Auxiliary Cat Katz: The Family Night Movie, Moana, is on September 23rd on the Patio at 6:00 PM. The Red Cross Blood Drive, is being held on October 9th from 10:00 to 4:00. The Children's Halloween Party is on Saturday, October 28th from 11:30 to 3:00. Troop Shipping is on Saturday, November 4th at 10:00 AM.
- c) ALYC Mike Berdine: They are close to having insurance for the Dive Club. The kick-off was held for the Sailing for the Visually Impaired event being held on October 7th. It is being held in conjunction with the Women's Sailing Association, and the Seal Beach Lions Club.
