3. Provide evidence of adequate insurance on the boat; and
4. Place an operable, safety compliant, seaworthy boat of qualified size which I own in the rented slip.

Failure to comply with any of these requirements within 30 days will result in forfeiture of the available slip; it will be offered to the next person on the Slip Waiting List; and I will be moved to the bottom of the Slip Waiting List.
