**COMMANDER:** Reminder that this meeting is conducted in accordance with Post 291 Bylaws & Roberts Rules of Order.

### Legion Family & Donations

- a) SAL Tim Sullivan, Commander Announced that they are having a fishing trip on July 26th.
- b) Auxiliary Kendall Madsen, Membership Announced they started renewals and membership yesterday. Mentioned Girls Nation. Mike Schubert stated that at the briefing he holds for new members before every meeting a member of the Auxiliary makes a membership pitch.

The Commander reminded everyone that a Legionnaire of the Post must be alive for their sons, daughters, husband or wife to join the Sons or Auxiliary. All members of the Post family should be working on getting new members into the Post.

c) ALYC – Rich Reyna, Vice Commodore – Mentioned they held a committee meeting in regards to their diving and snorkeling activities, and decided that this group will only function for information and social activities; there will be no on the water activities. # Financial Statement Executive Summary as of YTD 6/30/2018

JUDGE ADVOCATE – Speaking on the Post's Constitution, Bylaws, and Rules and Regulations.

The Commander spoke on issues regarding the SONS.

**SERVICE OFFICER** – Speaking on the Post 291 veteran's assistance programs. Jesse Garcia discussed two requests for donations.

- 1. The first was a request from Team Dark Horse that requested a \$5,000.00 donation to their Back to School event for Marine families.
