# **Legion Family & Donations**

- a) SAL Tim Sullivan, Commander Discussed their successful fishing trip held on July 26<sup>th</sup>; there were 15 on the boat. Mentioned they are volunteering on Saturday, August 4<sup>th</sup> at the Habitat for Humanity project in Tustin being built for a single disabled veteran. They donated \$5,000 to project. Another fishing trip is scheduled for September 27<sup>th</sup>. Discussed their next fund raiser that will be held later this year. Mentioned they are starting their planning for the Christmas Boat Parade event.
- b) Auxiliary Debbie Schubert, President Announced they received a very nice card from the Make-a-Wish Foundation for the 4<sup>th</sup> of July luncheon held at the Post. They have reached out to the Make-a-Wish Foundation to help with children of veterans. Last week they had a deployment part at Mile Square Park; they brought enough stuff to entertain 500 kids. They had 10 Auxiliary members show up for the WWII / Korean War event. Announced they have a project coming up in September; they are still working out the details. Mentioned their October 8<sup>th</sup> Blood Drive.
- c) ALYC Doug Green, Commodore Discussed their vacancy on their Board due to one of their Directors resigning. They formed a committee to oversee the process. They interviewed five members that expressed an interest in filling the vacancy. The committee selected Seveer Thomasson. Stated that repairs to the Valor (Yacht Club's boat) should take about three more weeks. They are waiting on a 30 foot strip of Mahogany for the rail. Discussed the Awards Dinner for the Old Glory Boat Parade held in July. There is a cruise the first weekend in August to Dana Point, and a fishing trip on August 18th.

#### COMMANDER

- Discussed the approved Honorary Members of the Post and asked the Board if we should keep them on the
  list. Those that are on the list, but have no connection with the Post should be removed. He mentioned that
  the SONS should do the same thing to clean up their membership list.
- Mentioned Skipper Tim and all the things he does using his boat to help veterans.
- Discussed the 100<sup>th</sup> American Legion Convention being held in Minneapolis from August 23<sup>rd</sup> to August 30<sup>th</sup>. Mentioned that 10 Board members and 8 Color Guard members are attending. Discussed the Commander's Banquet on August 28<sup>th</sup>, and the Hollywood Post's event on August 27<sup>th</sup>.

# **OFFICERS' REPORTS**

#### **1ST VICE COMMANDER** – Speaking about membership.

Mike Schubert announced that we that we are already at 25% renewal after the first month for this year. He stated that there are 70 new members this month. Discussed a joint activity between the American Legion and the American Legion Yacht Club; we are partnering with the Marina next door to offer adult sailing lessons to Legionnaires, and paddleboarding and kayaking; the flyer is on the webpage. After they complete the course the Post and Yacht Club will partner to pay 70% of their cost based on their certificate of completion and receipt. Approximately 30% of our new members are Post 9/11 veterans, and they are looking for things to do. We need to offer more for them to do in regards to water sports. Skipper Tim mentioned that veterans that complete the sailing class can continue their education on his boat, the Fair Wind; he is always looking for people for his crew.

# **2ND VICE COMMANDER** – Speaking about upcoming events and bands.

Anne Borren mentioned we have Gabby Lee coming on Thursday, Jazz Night on the Bay, and she is a new act. She's a one-woman act; she's her own one person band. Anne identified the list of bands that will be playing at the Post this month.

**3RD VICE COMMANDER** – Speaking on Americanism, youth and children, Boys State, and the Oratorical Contest. Sandy Schneeberger discussed the Boys State event. Announced that the governor was from Post 291, and that 3 of the 5 nominees for Boys Nation were from Post 291. One of the boys from the Post was selected as Boys Nation President. Mentioned she would like to hold a reunion event for last year's boys and this year's boys; she is expecting 30 or more boys to attend. The date is tentatively scheduled for the 19th of August.

The Board discussed the authorized signatures for the Post's Union Bank account.
