#### AL291 Donation Committee Report To the E-Board August 6, 2020

Donation Committee Meeting held on 7/15 via zoom.

Current Financial Results: 6521 Unrestricted Service Officer expense plus 6517 VEAF Restricted expense totaled up YTD \$36,056

Current balance in the VEAF restricted account is \$62,915.01

#### Veterans Served in July:

- A. Items approved or rejected:

  - 1. Brews (Navy) Rental Assistance because job cut hours from Loan Depot \$1200.
    2. Cruz (USMC) Student Veteran requested Rental Assistance for \$1300. Post 291 paid \$800 and Tierney Center will pay \$500. Referred from Coastline Community
  - 3. Rulon (USMC) Veteran was postal worker and broke leg in 3 places at work. Veteran's tires were unsafe, and amount was \$657.01 for a family of 6.

  - 4. Godeke (USMC) referred by Veterans Legal Institute needed assistance with public utility and water bills in the amount of \$465.55.

    5. Fitzgerald (Marine Spouse) husband was just killed and family needed rental assistance for the amount of \$1510.00. Post 291 paid \$755.00 and Families Forward
  - 6. Richins (Air Force) \$50.00 cellular phone bill. Rent was raised and is on set income.
  - 7. Ogata (Army) \$93.43 U-Haul that was initiated by American Legion HB and Battle Buddies Bridge helped with the move. Veteran has colon cancer.
  - 8. Pendleton (Navy) family needs help with Rental Assistance for \$700 as veteran lost iob and is awaiting unemployment benefits.
  - 9. Fleites (Army) pregnant reserve needed assistance with baby items for expected newborn due in August. Target card for \$250.00
  - 10. Knisley (Air Force) Senior Veteran needed rental assistance moving into Hero's
  - Landing at the Santa Ana Veterans Village for the amount of \$127.00.

    11. Martin (USMC) Father passed and paid half of the rent. Rental Assistance for \$1000.00 on apartment. Martin was laid off and will start getting unemployment in

# AL291 Marketing & Communications Committee (MCC) Report to the E-Board Minutes

Meeting held on Monday, July 20, 2020 5:00 p.m. – 6:00 p.m. ZOOM meeting hosted by Debbie Johnson at djohnson555@icloud.com

- A. Meeting called to order at 5PM.
- B. In attendance were Harold Smith, Nick Giordano, Hector Storman, Lynette Planto, Debbie Johnson, John Lindgren, Ken Wilson, Jeff Gottfredson, Cory Vigil and Chase Wickersham
- C. Discussion about the MCC and what it can accomplish. Reviewed the cancellation of the July 4<sup>th</sup> Post fund raiser. This event always raised \$25,000 to \$30,000 and was traditional. The MCC could have provided manpower to make the mailing on time and promote the sale of raffle tickets.
- D. Discussion of a new "Welcome to the Post" program. The MCC will organize personal calls to each new member within the first 30 days of being sworn-in at the General Meeting. Jeff reinforced the need for this. Strong support was indicated by all present. Ken and others commented on the success of the "Buddy call" program. It was suggested that a motion be made at the next E-Board meeting endorsing the program and asking for the contact information. The issue of security was discussed and the consensus was that the confidentiality of the membership information would be the responsibility of the MCC and each of its members. The draft script was reviewed without changes. Dennis was asked about this program and he encouraged an incentive (two for one entree offer for 30 days) to get new members to experience the Post.
- E. Discussion about how to help increase revenue from the "Take Out" program. The need for signage on the alley and around the parking lot was suggested. The consensus was that the MCC could help increase revenue with better promotion to all families associated with the Post. That lead to a discussion of the membership database and the need to update email addresses. This will require a mailing to get current contact information and ask for "opt in" permission. Jeff says that about 1000 Post members do not have email addresses. It will be necessary to reach some members by mail. Also, coordination with the AUX and SONS is essential to reach all Post families. Asking families to invite their friends will become important for expanding the reach of the program. Also discussed working with Fry's Market with joint marketing. A committee was formed (Lynette Planto and Harold Smith) to get more information and review options with Post leadership.
- F. Next meeting will be 8/17/2020 at 5PM. Meeting was adjourned about 6:10PM.

Today, the Post is mostly shut down, the bar is closed, but our kitchen is providing food for TAKE OUT and patio dining. The menu is posted daily and food can be picked up in the parking lot. Have you seen the daily menu? Let me send you the latest one. We just released our most recent newsletter, the SEABREEZE, which you should receive by email. Do you check email? YES or NO May I check your email address against our records? Would you "opt in" to receive email announcements and news from the Post in the future? YES or NO If you don't use email, would you like us to send you a printed version? YES or NO During this COVID-19 crisis, we continue to help our local veterans. Post 291 started the Veteran Emergency Assistance Fund (VEAF) last Fall and we continue

# On Going Post Operations — Rules

- · Drive-thru takeout meal service is available daily— and is open to the public
- For Post 291 Family members and their guests, outside dining at the Post is available daily — on the patios only
  - $_{\odot}\;$  Alcoholic drinks may only be ordered and served with a meal but refills permitted
  - o Masks must be worn to enter the patio areas and when not seated at a table
  - o Masks may be removed while seated at a table for eating and drinking
  - $_{\odot}\;$  When reordering drinks from the bar, masks must be worn If you get up, mask up!
  - Social distancing continues as a requirement
  - o Tables set up on the patios are purposely spaced at required distances
  - o Tables are cleaned after each set of users has departed

# AL291 Donation Committee Report To the E-Board June 4, 2020

Committee Meeting on 5/19 was cancelled but Zoom meeting held 5/26

Current Financial Results: 6521 Unrestricted Service Officer expense plus 6517 VEAF Restricted expense totaled for May so far \$3,133 or YTD \$26,166. Revised Forecast for 2020 is still \$70,000.

VEAF Memorial Day campaign update as of 6/3 from Tracey, we have received \$27,610 from 173 donors plus \$5500 from Vietnam Welcome Home party sponsors and \$25,000 from an anonymous donor (thanks to Doug Nye) for a total of \$58,110 with checks continuing to arrive at the Post. Current balance in the VEAF restricted account is \$67,731.

#### Veterans Served in May:

A. These veterans have received financial assistance in May:

- Stead (Coast Guard) homeless and living in a tent application for \$700 for emergency car repair to enable him to job hunt.
- Galloway (Navy) car repair for \$603 for a homeless veteran living at US VETS at Cabrillo Village.
- Brown (Air Force) disabled in a wheelchair struggling to pay rent and needed cash for food. Gave him two free meals at the Post takeout and sent him a \$20 Target card. Has requested help with utilities bill pending.
- 4. Light (Marine) OCC student 70% disabled paid \$570 for emergency car repair.
- Ellis (Marine) laid off from hospitality job requested rent assistance \$900.
- Campbell (Air Force) out of work, 80% service connected disability, asked for help to fix her car, paid deposit for \$300 plus \$45 for gift cards and one take out meal.
