

American Legion Newport Harbor Post 291 "Marina Rules and Policies"



I. Purpose:

- a. Provide documentation used for training and reference by all elected and appointed officers of the American Legion Post 291, by all members designated as the Officer of the Day (OD), and current appointed Dock Master of the American Legion Post 291.
- b. Clarify the rules and guidelines for all members of the Post.
- c. Reduce the risk of safety hazards and prevent improper use of Post 291 amenities.

II. General Rules:

- a. No swimming or fishing in the Marina.
- b. Kayaks, paddle boards, inflatables, etc. are not permitted in the inner channel of the Marina
- c. No "horseplay" or roughhousing on the Docks.
- d. Boat slips are exclusive for the use of Post 291 slip renters in their assigned space only.
- e. Post 291 slip renters, while visiting their boat, may park (1) vehicle per slip for (4) overnights per week.
 - i. Slip Renters are not guaranteed a parking space, they remain first-come, first-served.
- f. Guest dock is open every day for members visiting the Post during regular business hours.
- g. No visiting boats are permitted to be tied up in the red loading zone under the hoist.
- h. Unauthorized boat launching and landing is prohibited.
- Any use of the Post 291 Marina must comply with all appropriate provisions of the NBMC, Title 17 Harbor Code
- j. No operations which could be subject to a Marina Activities Permit (**NBMC 17.10**) are permitted anywhere in the Marina without written permission from Post 291.

III. Guest Dock:

- a. Authorized Users.
 - i. Any American Legion, Sons of the American Legion, or American Legion Auxiliary member from any American Legion Post.
 - ii. Members of ALYC approved reciprocal yacht clubs.
- b. General Daily Use.
 - i. Visitors may tie up during operating hours on a first-come, first-served basis for up to 8 hours max.
 - ii. Boats are limited to no more than 8 feet of draft and a beam of 14 feet.
 - iii. Upon arrival, the Skipper must immediately proceed to the Post 291 office (or bartender if the office is closed) to verify that the guest dock has not been reserved; and to provide information on Skipper, vessel, and an expected time of departure
 - iv. The first boat should go in as far forward as possible, leaving the remaining dock space available.
- c. Overnight Reservations.
 - i. Overnight stay is for authorized guests only. Reservations are required.
 - ii. Overnight stay is not permitted on Fridays and Saturdays.
 - iii. Overnight stay is not permitted on Sundays between the 1st Sunday in May thru Labor Day.
 - iv. Reservations can be made through the Post 291 business office during regular business hours
 - Monday Friday 9:00am 5:00pm

 - v. No reservations are available between Friday 12:00pm to Sunday at 5:00pm.
 - vi. Reservations are limited to no more than three consecutive nights.
 - vii. Overnight use of the guest dock is \$2.00 per foot per night with a \$50 per night minimum

- Payment of docking fees must be paid on arrival.
- A head and shower key and gate card are available with a \$100 deposit (refundable upon departure)
- viii. Upon arrival, the Skipper must immediately proceed to the Post 291 office (or bartender if the office is closed) to identify themselves, the vessel, its length, show proof of insurance, and vessel documentation/registration.

IV. Wet Slip Rental:

- a. Applicants must be a current Post 291 Legionnaire in good standing to be eligible for a slip rental.
 - i. SAL and AUX members are not eligible to rent slip spaces.
- b. Application fee for the initial application for a wet slip at the Post 291 Marina is \$100, which is due with the submittal of the Wet Slip Application.
- c. The annual renewal fee to remain on the waitlist is \$100, due no later than 31 January of each year.
- d. Limitations:
 - i. Post 291 facilitates forty-seven (47) wet slip spaces.
 - ii. Inside slips are a maximum of 30' vessel length.
 - iii. Outside slips are a minimum of 30' vessel length.
 - iv. Slips are rented to individuals only. No corporations or partnerships are allowed.
 - 1. Partnerships are defined as multiple names on the ownership and registration, that is not a legal spouse.
- e. Monthly rent is calculated at the appropriate rate, times the length of the vessel.
- f. Additional rules and requirements are detailed in the "Month-to-Month Marina Slip Rental Agreement"

V. Dry-Dock Storage Rental:

- a. Applicants must be a current Post 291 Legionnaire in good standing to be eligible for dry-dock storage rental.
 - i. SAL and AUX members are not eligible to rent dry-dock storage spaces.
- b. Application fee for the initial application for a dry-dock storage space at Post 291 is \$50, which is due with the submittal of the Dry-dock Storage Application
- c. The annual renewal fee to remain on the waitlist is \$50, due no later than 31 January of each year.
- d. Limitations:
 - i. Post 291 facilitates sixteen (16) dry storage spaces
 - ii. Vessels cannot exceed 14' in length and 1,500 lbs
 - iii. Dry-dock storage is rented to individuals only. No corporations or partnerships are allowed.
 - 1. Partnerships are defined as multiple names on the ownership and registration, that is not a legal spouse.
- e. Monthly rent is set at a flat rate as approved for the current year.
- f. Additional rules and requirements are detailed on the "Dry Dock Agreement"
